INFORMATIVE CLAUSES OF DATA PROTECTION REFERING TO APPLICATION FORMS

- ✓ **Bilbao Exhibition Centre, S.A. ('BEC')** with registered address in Ronda de Azkue 1, 48902 Ansio-Barakaldo as organizers of **+ INDUSTRY, Hardware and industrial supply sector**. For these effects, they are committed to collaborate in good faith to guarantee compliance with the obligations established in the field of data protection and, more specifically, to fulfil the exercise of your rights in compliance with the conditions established in this policy.
- ✓ The purposes of the processing of your data by **BEC** are (i) managing your participation in **+ INDUSTRY** and the contractual relationship that is generated as a result of your participation as an exhibitor in **+ INDUSTRY**, and (ii) keeping you informed of future events related to the sector that may be of interest to you.
- ✓ The personal data provided will be held by BEC until the termination of the legal relationship that resulted of your participation in **+ INDUSTRY**, or, where appropriate, until you exercise your right of opposition to the purpose (ii). As of this time, BEC may store your data, even blocked data, for a period of six years or for the limitation period of actions related to its responsibilities, when this period is in excess of the aforementioned.
 - ✓ The legal grounds for the processing of your data is for purpose (i) the implementation of the legal relationship between BEC as organizer and you, as an exhibitor, and for the purpose (ii) the legitimate interest of BEC, consisting respectively of raising awareness of events held at BEC, related to the sector, that may be of interest to the recipient.
 - ✓ BEC shall not share your information with third parties, unless legally required to do so.
 - ✓ You have the right to access, change or cancel your data, oppose their processing, oppose processing (for example, to stop receiving commercial information) or request the limitation of their processing or the portability of your data.
 - ✓ You may also choose to send any written requests that, in your case, may be appropriate, with the purpose of exercising the aforementioned rights with each of the co-responsible parties, separately, and proving your identity by means of BEC, through:
 - BEC: sending an email to protecciondedatos@bec.eu or a written letter addressed to the BEC's registered address (FAO Data Protection).
 - Likewise, if you wish not to receive further commercial communications from BEC, you may write to the email protecciondedatos@bec.eu to exercise your right of opposition. In addition, in each commercial communication that BEC sends you, the possibility of exercising this right of opposition will be offered in a clear and simple way.
 - ✓ Additionally, you are also entitled to present a claim against the Spanish Data Protection Agency (Data protection Control Authority). Further information at www.aepd.es
 - ✓ If the exhibitor provides third party data during their relation with BEC (e.g. employee, contractor or supplier), the exhibitor declares and guarantees that these third parties have been duly informed of this notice and, where appropriate, their consent has been requested, without BEC having to carry out any additional action in this respect.
